# Exercise your rights under GDPR

The GDPR regulation provides the following rights for individuals (data subjects):

### 1) Right of Access

All data subjects have the right to be informed whether any of their personal data is being processed by KH Chemicals, and where this is the case, have the right to access this data and to be provided with specific information about the processing of their personal data. This is known as the Right of Access.

=>If KH Chemicals is processing your personal data, and you want to access this personal data or want to be provided with specific information about the processing of your personal data, please make a formal request in writing by filling-out and printing enclosed contact form and including a copy of your ID card or passport (in order to verify the valid nature of your request) 1

#### 2) Right to Rectification or Erasure Procedure

All data subjects have the right to obtain the rectification or erasure of their personal data. This is known as the Right to Rectification or Erasure.

=>If KH Chemicals is processing your personal data, and you require KH Chemicals to rectify or complete inaccurate or incomplete personal data, please make a formal request in writing by filling- out and printing enclosed contact form and including a copy of your ID card or passport (in order to verify the valid nature of your request)<sup>2</sup>

#### 3) Right to Object

All data subjects have the right to object to the processing of their personal data. As a result of this objection, KH Chemicals will no longer process the personal data, unless one of the following applies:

- i. KH Chemicals demonstrates compelling, legitimate grounds for the processing, which override the interests, rights and freedoms of the data subject, or
- ii. Processing the personal data is necessary for the establishment, exercise or defense of legal claims.
- => If you want to object to the processing by KH Chemicals of your personal data, please make a formal request in writing by filling-out and printing enclosed contact form and including a copy of your ID card or passport (in order to verify the valid nature of your request)<sup>3</sup>

## 4) Right to Data Portability

All data subjects have the right to receive their personal data and have it transmitted to another data controller. This is known as the Right to Data Portability. This right applies only in the following cases and does not apply to paper files:

- Processing is subject to a contract or based on the consent of the data subject, and
- ii. Processing is carried out by automated means.
- => If KH Chemicals is processing your personal data, and you require KH Chemicals to transmit your personal data to another data controller, please make a formal request in writing by filling- out and printing enclosed contact form and including a copy of your ID card or passport (in order to verify the valid nature of your request)<sup>4</sup>
